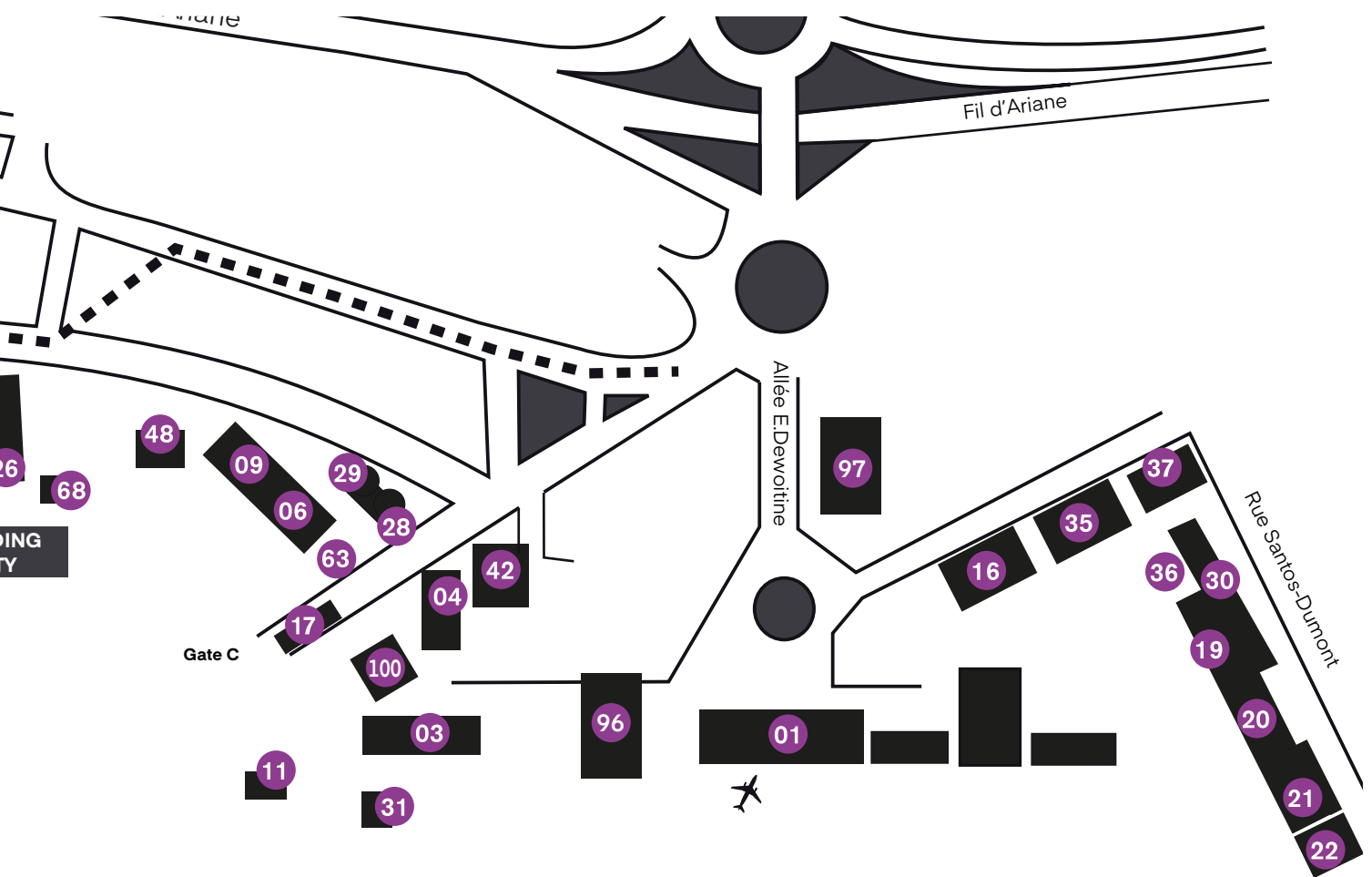

# general provisions

All authorisations to perform an activity given by the Aéroport Toulouse-Blagnac company are granted under the regime of authorisations to temporarily occupy publicly-owned State land.

## 1.1 invoice payment

### Payability

Invoices shall be paid within net 30 days of the invoice date. By way of exception, car park reservations and subscriptions, individual entries to the "La Croix du Sud" lounge, left items service and item shipping can be paid for at the time of ordering the service.

## 1.2 recovery

### Security for payment of invoices

Aéroport Toulouse-Blagnac may call for the implementation of the following guarantees:

- a security deposit of an amount equal to at least 3 months of fees, including tax,
- taking out a guarantee payable upon first demand with a bank approved by Aéroport Toulouse-Blagnac, the amount of which shall be assessed by Aéroport Toulouse-Blagnac on the basis, in particular, of the volume of the customer's activity.

**In the event of late payment:**

In the event of delayed payment, without formal notice of any kind being necessary:

- the amounts remaining due, for charges for occupancy or use of the public domain of a public entity mentioned in Article L1 of the general code on public property, shall include interest added at the legal rate.
- the outstanding amounts, relating to other non-aviation charges, shall include interest for late payment at three times the legal interest rate, and a fixed charge of €40 for recovery costs.

**In the event of non-payment:**

Aéroport Toulouse-Blagnac reserves the right to:

- call upon provided guarantees and call in provided deposits, on formal notice,
- demand the immediate payment of invoiced services,
- suspend services (water, electricity, telephone, access to car parks, etc.),
- initiate legal proceedings.

## 1.3 vat application

VAT applies to all non-aviation fees, at the normal rate, in compliance with the legislation in force.

## 1.4 processing of personal data

Personal data collected are processed by AÉROPORT TOULOUSE-BLAGNAC, which is responsible for processing in order to respond to requests and handle the execution of services. ## 5.3 premium pass

The PREMIUM PASS service offers preferential access to security screening and access to the LA CROIXDU SUD lounge. This service can only be offered to passengers declared eligible by the airlines; the applicable pricing terms and eligibility terms are as follows:

### Fixing of prices

For each airline, the applicable price is calculated according to the number of LOUNGE entries made by their passengers, as per the price list set out in Article 5.3, on the express condition that this number of entries totals at least 15% of the number of passenger passes through preferential security screening. The PREMIUM PASS service shall then be invoiced by monthly invoicing of the lounge entries.

If the number of LOUNGE entries is below 15% of the number of passenger passes through preferential security screening, the applicable rate will be calculated based on a fixed number of entries equalling 15% of the number of passenger passes through preferential security screening.

Example: for AAA airline, for 1,000 passenger passes through preferential security screening, if the number of LOUNGE entries equals 200, the applicable rate will be 200 x the rate for the "from 1 to 5,000 passenger/ year» bracket; if the number of entries only equals 100, which is below the fixed minimum of 150, the applicable rate will equal 150 x the rate for the «from 1 to 5,000 passenger" bracket.

The difference between the number of actual entries and the fixed number of entries shall be invoiced each month, added to the invoicing of the lounge entries and adopted for the cumulative total of the number of lounge entries for the following months.

### Eligibility

After declaring a passenger eligible, each airline must issue said passenger a travel document containing a computer code specifying the passenger's eligibility for the PREMIUM PASS service.

Were preferential security screening to be degraded, more restrictive acceptance criteria may be required after consultation with the airlines.
